PCTV96 RELEASE AGREEMENT

Whereas, PCTV96 City of Plainfield, (the "Producer") is engaged in a project (the "Video"), and

I expressly stipulate that the Releasees may utilize the Released Subject Matter or not as they choose in their sole discretion without affecting the validity of this Release. This Release shall be governed by New Jersey law.
