On January 1, 2006, Councilman Ray Blanco was elected City Council President for the Year 2006.

On January 1, 2006, Councilman Rayland Van Blake was elected City Council Chairperson, Committee of the Whole, for the Year 2006.

On January 1, 2006, Daniel A. Williamson, Esq. was appointed Corporation Counsel effective January 1, 2006, to serve at the pleasure of the Mayor.

On March 20, 2006, Carlton R. McGee was appointed City Administrative effective March 20, 2006 to serve a term concurrent with the Mayor (to January 1, 2010).

On March 20, 2006, Daniel A. Williamson, Esq. was appointed Corporation Counsel effective March 20, 2006 to serve a term concurrent with the Mayor (to January 1, 2010).

On July 28, 2006, Councilman-at-Large Ray Blanco, City Council President for 2006, passed away.

On August 23, 2006, the Plainfield City Council elected Harold Gibson as Councilman-at-Large to succeed Raymond Blanco, deceased, until the next General Election (November 7, 2006).

On August 23, 2006, Councilman Rayland Van Blake was elected City Council President for 2006 succeeding Raymond Blanco, deceased.

On August 23, 2006, Councilwoman Linda Carter was elected City Council Chairman, Committee of the Whole, for 2006 succeeding Rayland Van Blake.

On October 3, 2006, Carlton R. McGee resigned as City Administrator.

On December 6, 2006, Marc D. Dashield was appointed as City Administrator for a term concurrent with the Mayor (to January 1, 2010).

At the November 7, 2006 General Election, the following were elected:

Rashid Burney, Councilman-at-Large, 2nd and 3rd Wards, four-year term, January 1, 2007 to January 1, 2011

Rayland Van Blake, Councilman, 1st Ward, four-year term, January 1, 2007 to January 1, 2011.

Harold Gibson, Councilman-at-Large, unexpired four-year term of Raymond Blanco (deceased), November 7, 2006 to January 1, 2009.
