On January 3, 2011, Councilwoman Annie McWilliams was elected City Council President for the Year 2011.

On January 3, 2011, Councilman Adrian O. Mapp was elected City Council Chairperson, Committee of the Whole, for the Year 2011.

On January 3, 2011, a Communication from the Mayor dated December 17, 2010 appointed Daniel Williamson as Acting City Administrator and Jacques Howard as Acting Director, Department of Public Works and Urban Development.

On January 18, 2011, Vera Greaves was appointed by the City Council as Councilwoman-at-Large, First and Fourth Wards, for the term January 18, 2011 to November 8, 2011, to succeed Linda Carter who resigned on December 27, 2010 due to her election as Union County Freeholder.

On February 14, 2011, Abubakar Jalloh was appointed City Clerk for the three year term January 1, 2011 to December 31, 2013; and grant residency waiver. Mr. Jalloh succeeded Laddie Wyatt who retired on December 31, 2010.

On March 18, 2011, Bibi Taylor, City Administrator, submitted a Letter of Resignation effective March 18, 2011.

On April 11, 2011, a Communication from the Mayor dated March 30, 2011 appointed her Honor the Mayor, Sharon Robinson-Briggs, as Acting City Administrator as of March 30, 2011.

On June 20, 2011, a Communication from the Mayor dated May 11, 2011 appointed David R. Kochel as Acting City Administrator for a term of ninety days as of May 11, 2011.

On June 14, 2011, the City Council adopted Resolution No. 172-11 approving a Professional Services Agreement with Jersey Professional Management for David R. Kochel to serve as Acting City Administrator for ninety days as of June 14, 2011.

On July 5, 2011, the City Council adopted Ordinance No. MC 2011-05 which reverted the City to a Calendar Fiscal Year (January 1 to December 31) rather than a Fiscal Year (July 1 to June 30).

On August 8, 2011, the City Council adopted Ordinance No. MC 2011-07 which extended interim appointment terms for an additional period not to exceed ninety (90) days.

On August 8, 2011, David R. Kochel, an Associate of Jersey Professional Management was appointed Acting City Administrator for an additional ninety (90) day term.

On August 8, 2011, Jacques Howard was appointed Acting Director of the Department of Public Works and Urban Development for an additional ninety (90) day term.

On September 12, 2011, Eric E. Jackson was appointed Director, Department of Public Works and Urban Development, for a term concurrent with the Mayor (September 12, 2011 to December 31, 2013); and residency requirement was waived.

On November 1, 2011, David Kochel, an Associate of Jersey Professional Management, was appointed Acting City Administrator for the term November 7, 2011 to December 21, 2011.

On November 14, 2011, a Communication from the Mayor appointed Al Restano as Acting City Administrator effective November 14, 2011.

On November 21, 2011, Eric Berry was appointed City Administrator for a term concurrent with the Mayor (November 21, 2011 to December 31, 2013); and residency requirement was waived.

At the November 8, 2011 General Election, the following were elected:

Cory Storch as Councilman, Second Ward, for the four-year term, January 1, 2012 to January 1, 2014.

Vera Greaves as Councilwoman-at-Large, First and Fourth Wards, for the four-year term, January 1, 2012 to January 1, 2014.
