- Two (2) sets of floor plans showing the existing and proposed work.
- Elevation view of the structure identifying the finished floor elevation relative to mean sea level. NAVD1988.
- Structural details including foundation, floor, wall, ceiling and roof assemblies.
- Anchoring details of foundation, floor, walls and roof assembly. Building must be designed to resist all loads, including flood, wind and uplift, during flooding.
- Location of utilities (boilers, furnaces, air-conditioning, water heaters, pumps, duct work, etc.) All utilities must be above the DFE. All outdoor air-conditioning units, oil or propane tanks must be elevated and anchored above the DFE.
- The enclosed area below the DFE may be used for storage, parking, access to home or non-livable space.
- The finished ground level of an under floor space such as a crawl space must be equal to or higher than the outside finished ground level.
- All building material used below the DFE must be of flood resistant material.
- Flood Vents shall be provided for enclosed areas below the DFE. Flood Vents shall be provided at a minimum of 1 per every 200 sf of enclosed area. Each enclosed area shall have minimum of 2 flood vents. Flood vents to be installed no more than 12" above grade.
