### City of Plainfield Historic Preservation Award Nominations

Annually the Plainfield Historic Preservation Commission presents awards for outstanding achievements in local preservation. The aim of these Preservation Awards is to raise awareness of Plainfield's exemplary architectural character and encourage the continued stewardship of its historic buildings and homes. You are invited to nominate any individual, business, organization, building, and/or completed project that deserves local recognition.

#### **Preservation Project Award**

This award recognizes excellence in the restoration, rehabilitation, or adaptive use of historic buildings, structures, sites, or cultural landscapes. Judging standards include architectural integrity and compatibility, successful adaptation or continued use of a historic structure, quality of construction, craftsmanship, technical excellence, sustainability, green design, and/or urban revitalization through historic preservation. Projects may be of any size from entire buildings or homes to architectural details such as a porch reconstruction, window or roof replacement, new fencing, etc. All nominated projects must be physically located in the City of Plainfield and have been completed before October 1, 2015.

#### **Preservation Service Award**

This award recognizes extraordinary contributions to the better understanding of the City's history and to the preservation of Plainfield's historic architectural fabric. Individuals, businesses, and organizations are eligible and will be recognized for furthering public education and awareness of the City's history and promoting its historic preservation through projects, research, development, planning, advocacy, offices held, and local community leadership.
